

Special Measures for Enrollment Status and Tuition Concerning COVID-19

The following special measures have been implemented for students who have been adversely affected by the COVID-19 pandemic. If you wish to apply for any one of the special measures (1) to (7), first contact PEAK/GPEAK Section to obtain the necessary application documents and then submit the completed documents to PEAK/GPEAK Section by the submission deadline below.

(1) Special Extension of Enrollment Period

[Apply to] Students who were expected to graduate in March 2021 and will complete the maximum period of enrollment in March 2021

The special extension enables students who were not able to complete the program because of the interruption of their studies or research due to the influence of COVID-19 to further extend their enrollment period beyond the maximum period of enrollment at the university. The period impacted by COVID-19 may be counted as the exemption period of the tuition fee for the academic year 2021.

(2) Special Measure for Extension of Graduation

[Apply to] Students who will be graduating on March 19, 2021

The special extension enables students to remain a student even if they have satisfied all the requirements for their degree. The period impacted by COVID-19 may be counted as the exemption period of the tuition fee for the academic year 2021.

(3) Long-term Study System

[Apply to] All current students

The COVID-19 reason has been newly accepted for the Long-term Study System. You will be allowed to extend your study duration under the Long-term Study System even from the middle of the academic year or your final academic year.

(4) Special Measure for Extension of Enrollment Period

[Apply to] April entry students who were expected to graduate in March 2021

The special measure enables students who were not able to complete the program in March 2021 because of the interruption of their studies or research due to the influence of COVID-19 to extend their enrollment period with the special measure for the tuition fee payment. The period impacted by COVID-19 may be counted as the exemption period of the tuition fee for the academic year 2021.

(5) Leave of Absence

[Apply to] All current students

The COVID-19 reason has been newly accepted for taking a leave of absence. The period of this special leave of absence will not count towards the total amount of time that you can take a leave of absence (Master: 2 years, Ph.D. : 3 years).

Note: The available period for the special leave is until March 2022.

(6) Special Measures in Future

[Apply to] All current student

If your research has been significantly impacted by the pandemic in the academic year 2020 and you expect the above special measures to apply to you in the future, **make sure to complete the application procedures by the following deadline since the applicability for the special measures in the future will be decided based on your application this academic year (AY2020).**

(7) Others

If the pandemic has necessitated you withdrawing from the university, special measures for readmission may apply to you. Please contact us to learn more about the application procedures.

[Submission Deadline] (strictly observed)

(1) and (2) February 12 (Fri), 2021

(3) to (7) March 2 (Tue), 2021

Note: As for (5), up to one month prior to the start date of the leave.

[Submit to] PEAK/GPEAK Section (Counter No.2, 1st Floor, Admin. Bldg.)

Note: E-mail submission is also acceptable.

[Notice of Result for Special Measures]

(1) and (2) Around March 10, 2021

(3) to (7) Around the end of April 2021

Note: A written statement from your academic advisor is required for all the special measures. Please consult with your supervisor first if you intend to apply. In addition, these special measures will apply to you only if your department, program, and the graduate school approve your application.
