The University of Tokyo provides support to Ph.D. students engaged in academic activities that promote their research.

Grant period: Six months (from October 2019 to March 2020)

Grant amount: 50,000 yen per month

Payment category: Salary

Number of grantee: 76 Ph.D. students of the Graduate School of Arts and Sciences for AY 2019.

The number is proportionally allocated to departments, courses and programs based on the enrollment over the past three years.

Eligibility: Ph.D. students enrolled in the Graduate School of Arts and Sciences are eligible to apply (*).

- *Eligible students include:
 - a. those who have already completed the standard term of study;
 - b. those who have received this grant before;
 - c. those who are officially on leave of absence at the time of application and will return to school by October 2019;
 - d. those who are Japanese Government (MEXT) Scholarship recipients at the time of application and whose period of scholarship ends before October 1, 2019;
 - e. those who will enroll in the PhD program in September 2019.
- *Students ineligible includes:
 - a. those on leave of absence;
 - b. those with a JSPS Research Fellowship for Young Scientists;
 - c. those with a grant(s) from the Program for Leading Graduate Schools;
 - d. those with a Japanese Government (MEXT) Scholarship.
 - e. those with a grant(s) from World-leading INnovative Graduate Study Program

Please note a grantee will be disqualified if any of the above five criteria take effect during the grant period.

Selection Criteria: Selection is based on criteria set by each department, course or program.

Application Process: Submit the following documents to the PEAK/GPEAK Section by the deadline.

Place (1) Form 1 and (2) Supplementary Form in order and staple in the upper left-hand corner.

- (3) Self-addressed 82-yen stamped reply envelope (Naga-gata No.3:120 mm x 235 mm)

Application Period: From July 26 (Fri.) to 31 (Wed.) 2019 (Office hours: 9:00 am to 4:50 pm) All application materials should be submitted to: PEAK/GPEAK Section, Academic Affairs Division Note:

- Applicants will be notified of the selection results by post mail in late August. The documents required for payment will be sent to the grantee together with the results. Make sure to complete all procedures during the designated period.
- Applicants whose period of stay will expire during the grant period must contact the PEAK/GPEAK section in advance.
- Applicants whose resident status in Japan is not "Student" must contact the PEAK/GPEAK Section in advance.
- The grant's monthly allocation will be paid on the 17th of the following month (or on the 15th if the 17th falls on a Sunday, or on the 16th if the 17th falls on a Saturday, or on the 18th if the 17th falls on a holiday stipulated in the Act on National Holidays (Act No. 178 of 1948)).
- The grant is considered es a salary, and therefore, income tax will be deducted from the monthly allocation.
- The grant may be terminated at any time during the grant period if a grantee should fail to perform his/her academic research properly or commit a fraudulent act. Also, a grantee may request to terminate the grant for his/her own reasons.
- If a grantee takes a leave of absence, withdraws from the university, or completes his/her research during the grant period, the grantee must terminate the grant.
- After completing his /her research, the grantee must submit an Accomplish Research Report to the PEAK/GPEAK Section.
