(1) Special Measure for Extension of Enrollment Period with Special Tuition Waiver [Applies to] Students who will complete (or have already completed) their standard program duration (M.A.: 2 years, Ph.D.: 3 years) in August 2022 and were expected to graduate in August 2022. (See page 1 in Academic Handbook) [Only for international students whose status of residence is "College student" and need consideration for not being able to stay in Japan while taking a leave]

The special measure enables students who were not able to complete the program in August 2022 because of the interruption of their studies or research due to the influence of COVID-19 to extend their enrollment period with the special tuition waiver. The period impacted by COVID-19 may be counted as the exemption period of the tuition fee for the academic year 2022. This period will be determined by your academic supervisor etc.

(See page 1 in Academic Handbook) [Those who do not applicable to the condition stated in (1)]

The special measure enables students who were not able to complete the program in August 2022 because of the interruption of their studies or research due to the influence of COVID-19 to extend their enrollment period with the special tuition waiver. The period impacted by COVID-19 may be counted as the exemption period of the tuition fee for the academic year 2022. This period will be determined by your academic supervisor etc.

Any reasons related to the impact of COVID-19 is as eligibility for taking a leave of absence. The period of this special leave of absence will not count towards the total amount of time that you can take a leave of absence (Master: 2 years, Ph.D.: 3 years).

Note: The available period for the special leave is until March 2023.
