

Notification on Selection Results for Tuition Fee Exemption/Deferment for the Second Half, AY 2019

The selection result of Tuition Fee Exemption/ Deferment has been notified. Each applicant who applied Tuition Fee Exemption/ Deferment must check the result of their application as bellow.

- **Tuition Fee Exemption:** please check the page at UTAS(The method of checking is described in page 3 & 4).
- **Tuition Fee Deferment:** please check the document by postal mail.

[Tuition Fee Account Withdrawal Date]

▶Applicants with 50% tuition exemption accepted, or exemption/deferment rejected:

December 27 (Fri)

▶Applicants with tuition deferment accepted:

- Deferred payment accepted: March 27 (Fri), 2020

- Installment payment accepted: the 27th every month

- * However, please note that the tuition fee for the first three months (October to December) will be withdrawn from your account in one installment (on December 27). For those who enrolled in September, 2019, the tuition fee for the first four months (September to December) will be withdrawn from your bank account in one installment (on December 27).

⟨Important Notice to Applicants with Tuition Deferment Accepted⟩

The withdrawal dates mentioned above do not apply to cases where any changes in your school registry occur (leave of absence, withdrawal from university, graduation from (completion of) university, etc.) during this term. In addition, for students who are expected to graduate or complete the program in this term, the withdrawal date can be earlier than the above dates even if they are applicants with tuition deferment accepted. Regarding the payment of tuition fees, please confirm with the staff member of your Faculty or Graduate School.

*Please deposit the amount equivalent to the said payment for tuition fee into the direct debit account by 3PM on the day before the withdrawal date (If the date falls on a non-business day for your banking institution, be sure to deposit the amount by the business day prior to the withdrawal day).

*An invoice will be sent by the University Accounting Group to the student without direct debit account.

*Please note that this result does not apply to the Tuition Fee exemption/Deferment for the first half next Academic year. Students wishing to apply for the exemption need to submit the application again.

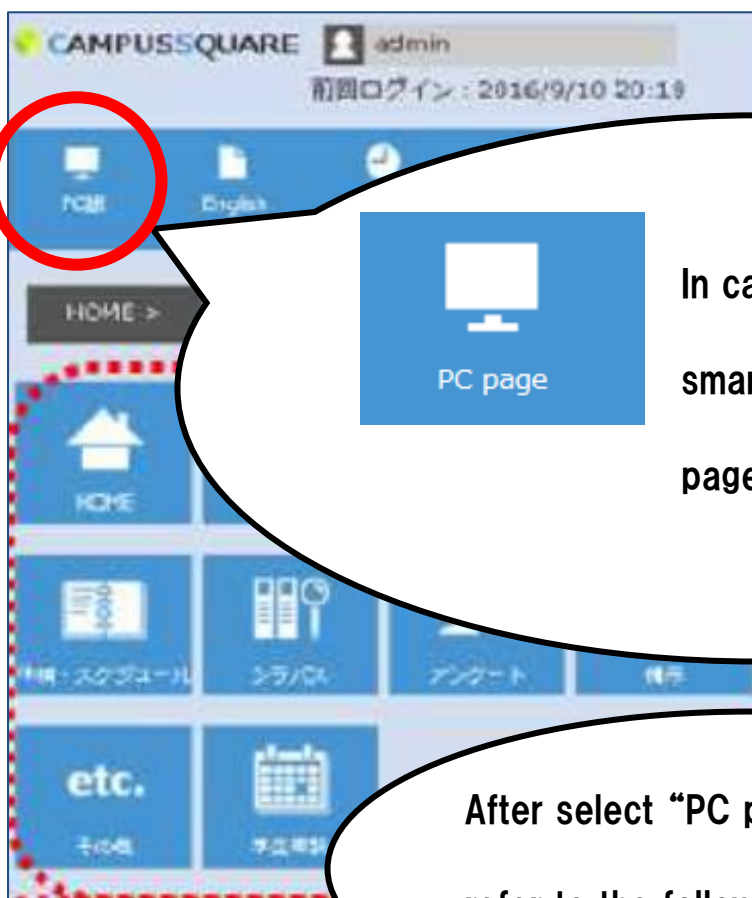

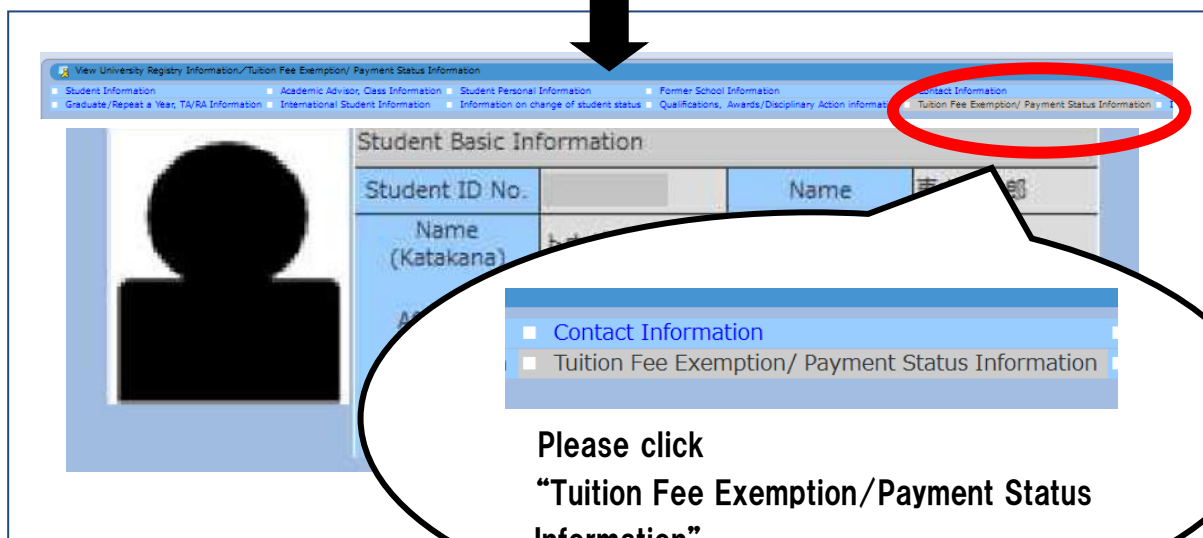
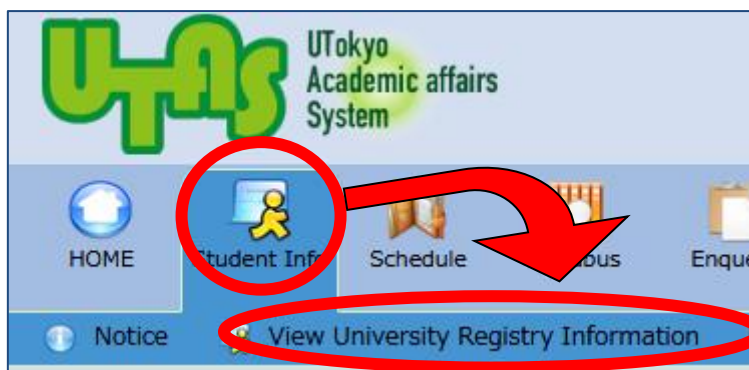
