

**Application Procedure Exemptions/Deferred Payment of Tuition Fee for the First Half of AY 2026  
For Students of the College of Arts and Sciences, the Graduate School of Arts and Sciences, the Graduate  
School of Mathematical Sciences**

**1. Eligibility**

**Those who are students at the College of Arts and Sciences, the Graduate School of Arts and Sciences, or the Graduate School of Mathematical Sciences, (excluding research students and auditing students) as of April 1, 2026, to whom one of the following applies:**

- a) Students who have difficulties in paying tuition due to economic reasons and who are recognized as having outstanding academic capabilities.
- b) Students who are recognized as having extreme difficulties in paying tuition due to the following reason:
  - Damages sustained by students or the persons responsible for the payment of their school expenses caused by wind, flood or other natural disasters.
- c) Students who are recognized as having other unavoidable circumstances.

**2. Application Process**

**【Application Period】**

Students entering in April 2026

(Fri)Feb.13,2026 – The last day of the admission procedure for their affiliated graduate school

\* The deadline for applying for only the tuition fee exemption is April 3.

Current students (Undergraduate/postgraduate students enrolling in the same course as AY2025)

(Fri)Feb.13,2026 – (Fri)Apr.3,2026

**【How to submit】**

We accept applications sent through the post. Please send applications by registered mail “簡易書留郵便” to address below. Application documents must be postmarked by the application deadline and arrive by 2 business days later.

If you wish to submit applications at the counter, we accept application documents submitted by the application deadline.

### 3. Selection Results

The result of the selection will be released around the end of July through the UTokyo Academic affairs System (UTAS).

- If the tuition exemption has been granted, either the entire or half of the tuition fee will be waived, depending on the household's financial circumstances.
- If the deferred payment has been granted, this will take the form of a deferral until the end of August, or payment in instalments until September.

### 4. Application of Deferred payment

Once the application of exemption is submitted, the payment of the tuition fee will be deferred until the results are determined (the end of July).

If you need more deferment (until the end of August), please contact us by email.

### 5. Precautions

(1) Undergraduate and graduate students who do not belong to the College of Arts and Sciences, Graduate School of Arts and Sciences, or the Graduate School of Mathematical Sciences must submit their applications to a different office. For more detailed information, please contact the office below.

(2) Applications submitted after the deadline will not be accepted whatever the reason. Please prepare well in advance and apply as early as possible.

(3) If you want to continue your tuition fee exemption, you must apply each academic year. Please note that the results of the application for AY2025 will not be automatically carried over to AY2026. Those who wish to receive tuition fee exemption for the AY2026 must apply.
