

Notice about the result of Admission/Tuition Fee Exemption for the First Half of AY2025

The purpose of this program is to help students who excel academically but suffer economic hardships so that they do not give up continuing their academic studies. We appreciate your full understanding of our efforts to operate the exemption program under a very tight budget.

How to check the Admission Fee Exemption result

Please log in to UTAS and check the “Bulletin Board” > “Newly Arrived” > “Administrative messages” section.

How to check the Tuition Fee Exemption result

Please log in to UTAS and check the “Student Info” > “View University Registry Information” > “Tuition Fee Exemption/Payment Status Information” section.

Payment Instructions for Tuition Fees

Please note that the scheduled Direct Debit Payment Date is **Wednesday, August 27**. Students who have been approved for reduced payment, or whose application for tuition fee exemption has not been approved, and who have arranged for direct debit payments, should ensure that the equivalent amount of their tuition fees is deposited into their account by 15:00 on Tuesday, August 26. Students who have not registered for direct debit should pay their tuition fees according to the invoice that will be sent by the Accounting Group around late August. If you have not yet arrived in Japan, please contact the academic affairs office of your affiliated faculty or graduate school for instructions on how to pay your tuition fees.

Tuition Fee Exemption for the Second Half of AY2025

If you have already applied for both the first and second half together, you do not need to apply again for the second half. However, if there are any changes in the situation of your family finances or your family members from the previous application, or if you change your course of study from the second half (e.g., from a master's to a doctoral course), you will need to reapply for the second half. Furthermore, please note that the results of the application will not be automatically carried over to the second half. The exemption from tuition fees for the second half will be determined through another screening process. With regards to the exemption from tuition fees for the second half, please check the details on our website or bulletin boards.

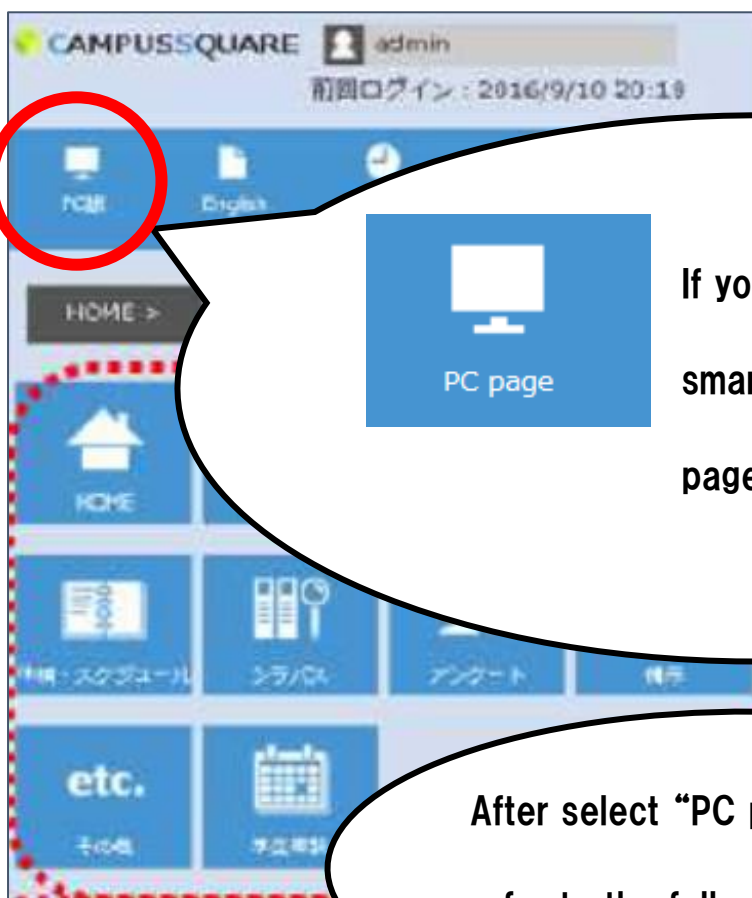

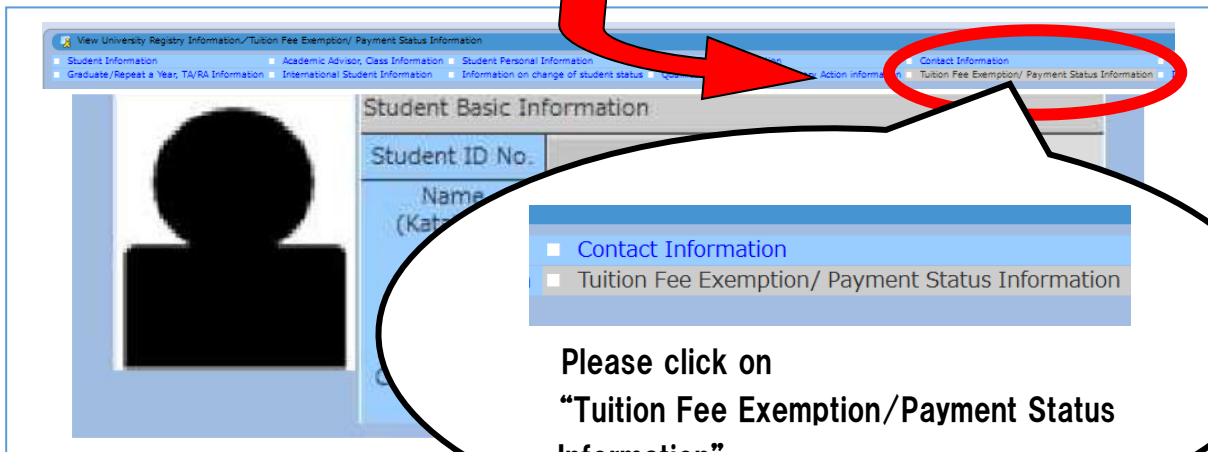
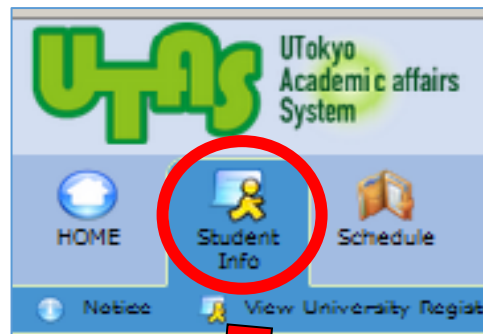
