#### Withdrawal of tuition fee

Please note that <u>Monday</u>, <u>August 28</u> is the scheduled withdrawal date. Students who have been approved for reduced payment or have had their application for tuition fee exemption rejected and have arranged to pay their tuition fees by direct debit, should make sure they have deposited the amount equivalent to their tuition fees into their account by 15:00 on Friday, August 25. Students who have not registered for direct debit should pay their tuition fees in accordance with the invoice that will be sent by the Accounting Group around mid-August. If you have not arrived in Japan yet, please contact the academic affairs office of your affiliated faculty/graduate school about how to pay your tuition.

## Tuition Fee Exemption for the Second Half of AY2023

If you have already applied for both the first and second half together, you do not need to apply again for the second half. However, if there are any changes in the situation of your family finances or your family members from the previous application, or if you change your course of study from the second half (e.g., from a master's to a doctoral course), you will need to reapply for the second half. Furthermore, please note that the results of the application will not be automatically carried over to the second half. The exemption from tuition fees for the second half will be determined through another screening process. With regards to the exemption from tuition fees for the second half, please check the details on our website or bulletin boards.


