

Special Measures for Enrollment Status and Tuition Exemption Concerning COVID-19

The following special measures have been implemented for students who have been adversely affected by the COVID-19 pandemic. If you wish to apply for any one of the special measures (1) to (5), first contact PEAK/GPEAK Section to obtain the necessary application documents and then submit the completed documents to PEAK/GPEAK Section by the submission deadline below.

(1) Special Extension of Enrollment Period

[Applies to] Students who were expected to graduate in March 2021 and will complete the maximum period of enrollment in March 2021

The special measure enables students who were not able to complete the program because of the interruption of their studies or research due to the influence of COVID-19 to further extend their enrollment period beyond the maximum period of enrollment at the university. The period impacted by COVID-19 may be counted as the exemption period of the tuition fee for the academic year 2021.

(2) Special Measure for Postponement of Graduation

[Applies to] Students who will be graduating on March 18, 2021

The special postponement measure enables students to remain enrolled even if they satisfy all the graduation requirements. The period impacted by COVID-19 may be counted as the exemption period of the tuition fee for the academic year 2021.

(3) Long-term Study System

[Applies to] All current students

Any reasons related to the impact of COVID-19 have been newly accepted as eligibility

for the Long-term Study System. You will be allowed to extend your study duration under the Long-term Study System even from the middle of the academic year or your final academic year.

(4) Special Measure for Extension of Enrollment Period

[Applies to] April entry students who were expected to graduate in March 2021

The special measure enables students who were not able to complete the program in March 2021 because of the interruption of their studies or research due to the influence of COVID-19 to extend their enrollment period with the special tuition fee waiver. The period impacted by COVID-19 may be counted as the exemption period of the tuition fee for the academic year 2021.

(5) Special Measures for Possible Future Applications

[Applies to] All current student

If your study/research has been significantly impacted by the pandemic in the academic year 2020 and you are considering applying for (4) above in the future, **make sure to complete the application procedures by the following deadline since the applicability for the special measures in the future will be decided based on your application in this academic year (AY2020).**

[Submission Deadline] (strictly observed)

Noon, March 1 (Mon), 2021

* E-mail submission is also acceptable.

NOTES:

- Upon application, it is necessary not only to have been affected by COVID-19, but also to be unable to recover afterward. (The reason for not achieving recovery should be limited to COVID-19.)
- These are special measures and do not apply to any students other than those who are expected to graduate or complete their studies. Please note that the decision to apply these measures will be made meticulously at the discretion of the faculty and not based solely on the student's application.
- Applications will be carefully deliberated by the committee and the results will be notified to the applicant by email before mid-March.
- A written statement from your program director must be attached to every application for all the special measures.
