Requirements for Permission of Utilizing Papers Presented to the University of Tokyo Academic Institutional Repository (UTokyo Repository)

(Objective)

1. Manuscript data of the papers (academic dissertation, papers already published on academic journal, etc.) written by the author himself/herself which are free from any conflict of interest with publishers or coauthors shall be registered to UTokyo Repository and shall be released to the public (inside and outside the University of Tokyo) to support for educational and learning activities and to contribute to the promotion of academic researches.

(Downloading and printing of full text)

2. The user shall be allowed to download or print full text of the paper stored in the UTokyo Repository.

(Electronic release)

- 3. The University of Tokyo Library shall duplicate the digitized papers (hereafter referred to as "electronic data") on the server and release the duplicate to the public through the network.
- 4. The electronic data shall be prepared to be transmissible in standard computer environments on the information network.
- 5. The electronic data shall be searchable using bibliographic information and the like.

(Conditions for utilizing electronic data)

- 6. The University of Tokyo Library shall conform to the following particulars for utilization of electronic data:
- a) The copyrighted work and expression of the title shall not be altered. However, such a portion that cannot be expressed appropriately in the technical environments specified under 5 above may be omitted or replaced with other alternatives.
- b) The author credit and copyright shall be clearly shown.
- c) Prior to the release, cautions shall be posted reminding the user to adhere to the copyright law in utilizing the electronic data.
- 7. The scope of transmission of the electronic data shall be inside and outside the University of Tokyo.
- 8. The coverage of the electronic data release shall be the full text of the paper.

(However, in some cases only the abridged version of doctorate theses may be released.)

- 9. The utilization of the electronic data shall be free of charge.
- 10. The University of Tokyo Library shall not be responsible for any of consequences attributable to the utilization of the electronic data by the user.

(Permission for utilization of copyrighted works)

- 11. The person who permits the utilization as listed on the front (hereafter referred to as "licenser") shall agree with the University of Tokyo Library for utilization of the copyrighted work based on the contents of permission shown on the front.
- 12. In the event there is copyright owner other than the licenser (for example, there are plurality of copyright owners or the paper concerned includes a computer program developed by other than the licenser), the licenser shall acquire in advance the permission for utilization by other copyright owners.
- 13. The licenser shall provide sufficient adjustments in advance with all related persons and parties so that, in utilizing the paper concerned, there may not arise any dispute with the third parties. (For example, such a case where the paper concerned has already been made public by other publishers.)

(Modification of requirements for utilizing papers)

14. When the licenser wishes to alter the requirements for release, he/she can submit alternation of the requirements with reasons for it.

(Cancellation of release)

- 15. When the licenser wishes to cancel the release, he/she can submit cancellation of the release with reasons.
- 16. In the event any fact of inadequacy should be detected with the release, the University of Tokyo Library can notify the licenser of cancellation of the release with reasons.

(Others)

17. Items not covered by this permission of utilization shall be discussed separately, as necessary, by the licenser and the University of Tokyo Library.
