Title: Remote Sensing, Geographical Information Systems and Analysis: Theory and Application

Lecturer: Dr. Kikuko Shoyama

Course Description:

The course aims to provide a broad understanding of the spatial analysis techniques and their use in aspects of environmental research, management and policy making. This course is divided into two parts: (1) Methods, Theory and Practice of Spatial Analysis using GIS and (2) Principles of Remote Sensing and Practice on Digital Image Processing. First part session will introduce fundamental concepts of GIS including GIS data storage, coordinate systems, and spatial analysis using GIS to display, interrogate and analyze spatial data. The second part of this course is designed to cover the basic principles of Remote Sensing and Image Interpretation, which cover basics about Remote Sensing Techniques, various satellite systems, and further about Digital Image Processing, image classification, and applications. Practical hands-on experience to process satellite data using ArcGIS in particular is also part of the course. This will be achieved through a series of lectures and hands-on guided training sessions in a variety of application areas that will equip the student with both the theoretical and practical skills to use GIS in future research work. The course is designed around ArcGIS – the world's leading GIS software package.

Learning Outcomes:

The course aims to familiarize students with the theoretical background and practical application of Remote Sensing and GIS. Student will learn the importance of spatial data and how to process satellite data to acquire useful information and their interpretation to solve various global environmental problems. They can also utilize this technique to handle various spatial data in creating, producing and analyzing various maps. The assessment of the course is multifaceted with theoretical, practical and managerial elements assessed. By the end of the course, student should be able to understand and organize spatial data in order to solve geographic problems using GIS.
